

## **Ultimate South Africa Honeymoon Sweepstakes**

### **TERM:**

**Ultimate South Africa Honeymoon** Sweepstakes (the "Sweepstakes") entry period commences at 12am Eastern Standard Time on December 30, 2010, and ends at 11:59 pm Eastern Standard Time on February 28, 2011 (the "Sweepstakes Entry Period").
