

The Knot Guest App by The Knot Sweepstakes

TERM:

The Guest App by The Knot Sweepstakes (the "Sweepstakes") entry period commences at 12:01 a.m. Eastern Time on October 1, 2018, and ends at 11:59 p.m. Eastern Time on December 31, 2018 (the "Sweepstakes Entry Period"). The Sweepstakes is sponsored by XO Group Inc., 195 Broadway, 25th Floor, New York, NY 10007 ("Sponsor").

ELIGIBILITY:

This Sweepstakes is open to any legal resident of the 50 United States, and the District of Columbia, 18 years or older as of date of entry.
